OPEN CALL MAIN FEATURES

- BUDGET 400.000 euros
- The promoters will be able to submit their proposals from the date of 1 January 2021.
- The promoters may apply for a maximum grant of 80.000 euros
- Publicity was given via website (eeagrants.gr)/ Facebook (promoted post)/Twitter/Instagram and a e-Press Report (paid press release)

OPEN CALL MAIN FEATURES

Maximum grant per project is €80.000 In exceptional cases, under a well documented justification in relation to the evaluation criteria, JCBF may examine and approve selection of projects beyond this line.

The projects will be financed through the Public Investments Program. The expenditure is eligible by 100% for EEA FM funding.

Eligible entities:

Each project must be implemented in partnership of at least two entities, one from Greece and one from Norway. For better implementation delivery, the role of the initiative promoter is recommended for entities based in Greece.

The entities falling under the following categories may apply /participate as promoters or partners:

Central government, regional and local authorities

Universities, research and scientific bodies

Other Entities of Public Law

Non Governmental Organisations, Chambers and Professional associations, etc

Other competent entities actively involved in, and effectively contributing to areas and goals addressed by the project proposal

At the stage of project proposal and selection a letter of intent by the partners of the project should be submitted with the project proposal. After selection and before the commencement of implementation, a project partnership agreement must be signed between promoters and partners of each project.

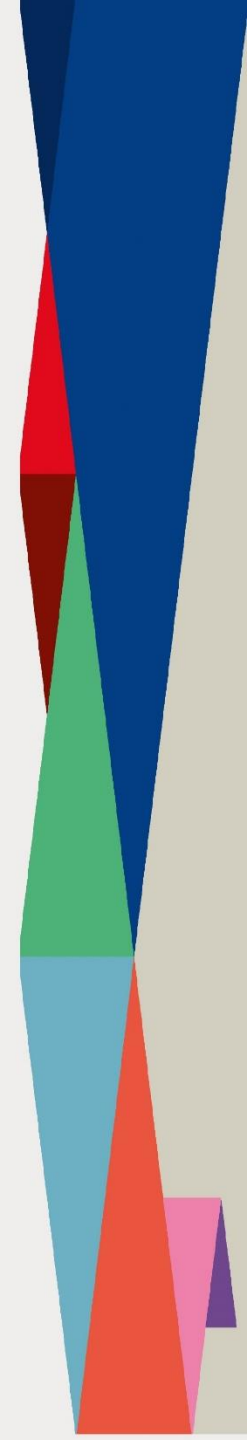

Youth Employment and Gender Equality: Mobilizing human capital for sustainable growth in Greece (Stage 1)

Final Progress (10 Greek staff/4 Norwegian staff involved)

The communication of the on-going research and its results, via the agreed deliverables as well as additional output, took place throughout the duration of the project. The project started with an online Kick-off Meeting in October 2020, where the project timeline and methodology were discussed and determined.

The desk research from the project researchers resulted in the preparation of the following **project deliverables**:

- Two papers that map the labour market and related policies in Greece (with an emphasis on the young and women respectively) (ELIAMEP)
- Two papers on the role of the Greek education, training and skills development in enabling youth and early career women to access to the labour market: one paper on the vocational education and training system and one paper on the higher education and research and innovation system (ELIAMEP)
- A report on the Scandinavian experience of integrating the youth and women into the labour market (Fafo)
- In parallel, the Youth Survey was designed by the research team and took place in April 2021 (with a booster survey in October 2021), and the resulting data were analysed. A paper was prepared on the survey findings. (ELIAMEP)
- In addition, given the circumstances of the past two years, a paper on the impact of the pandemic on the Greek labour market was also prepared by ELIAMEP.
- A final brief paper on 'EU Policy and Financial Instruments for Youth and Women Access in the Labour Market' was also produced (ELIAMEP)

The aforementioned papers, following appropriate editing, will form the bulk of the final report, which will be completed in November and presented in December 2021. It will be available on the project web page on ELIAMEP's website.

Project Deliverables

The desk research from the project researchers resulted in the preparation of the following project deliverables:

- ; A final report of the geopolitical study entitled “From Hydrocarbons to Renewables: Rethinking Energy Geopolitics in the Eastern Mediterranean”, including an executive summary and the main findings and conclusions based on the analysis carried out.
- ; A final Social Impact Study Report that includes an executive summary and the study’s findings.
- ; A working model of the cost-benefit analysis (CBA) built in Excel. This is easily accessible to users without a technical background, allowing them to understand both how the models work and how input parameters and assumptions might be altered.
- ; One closed workshop to discuss the findings of the Social Impact Study with policy makers, representatives of the EEA Donor States and civil society.
- ; One public webinar for the presentations of results for the Geopolitical Study.
- ; 4 opinion pieces.
- ; Two infographics accompanying the geopolitical study and the social impact study for wider dissemination on social media.

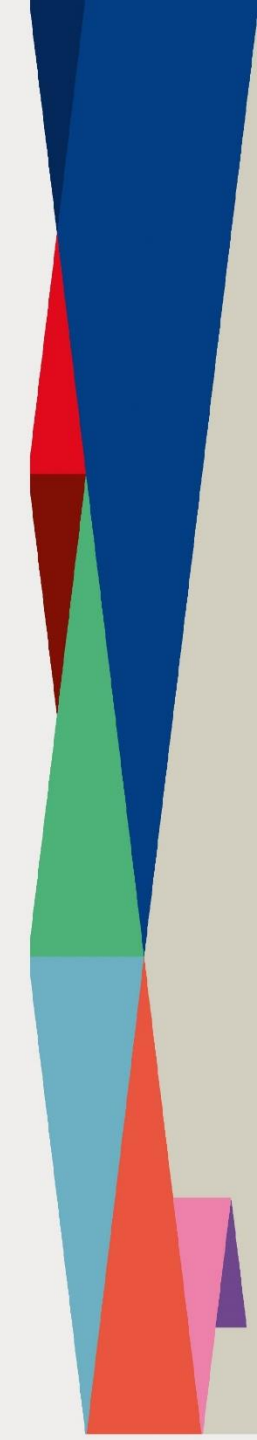
