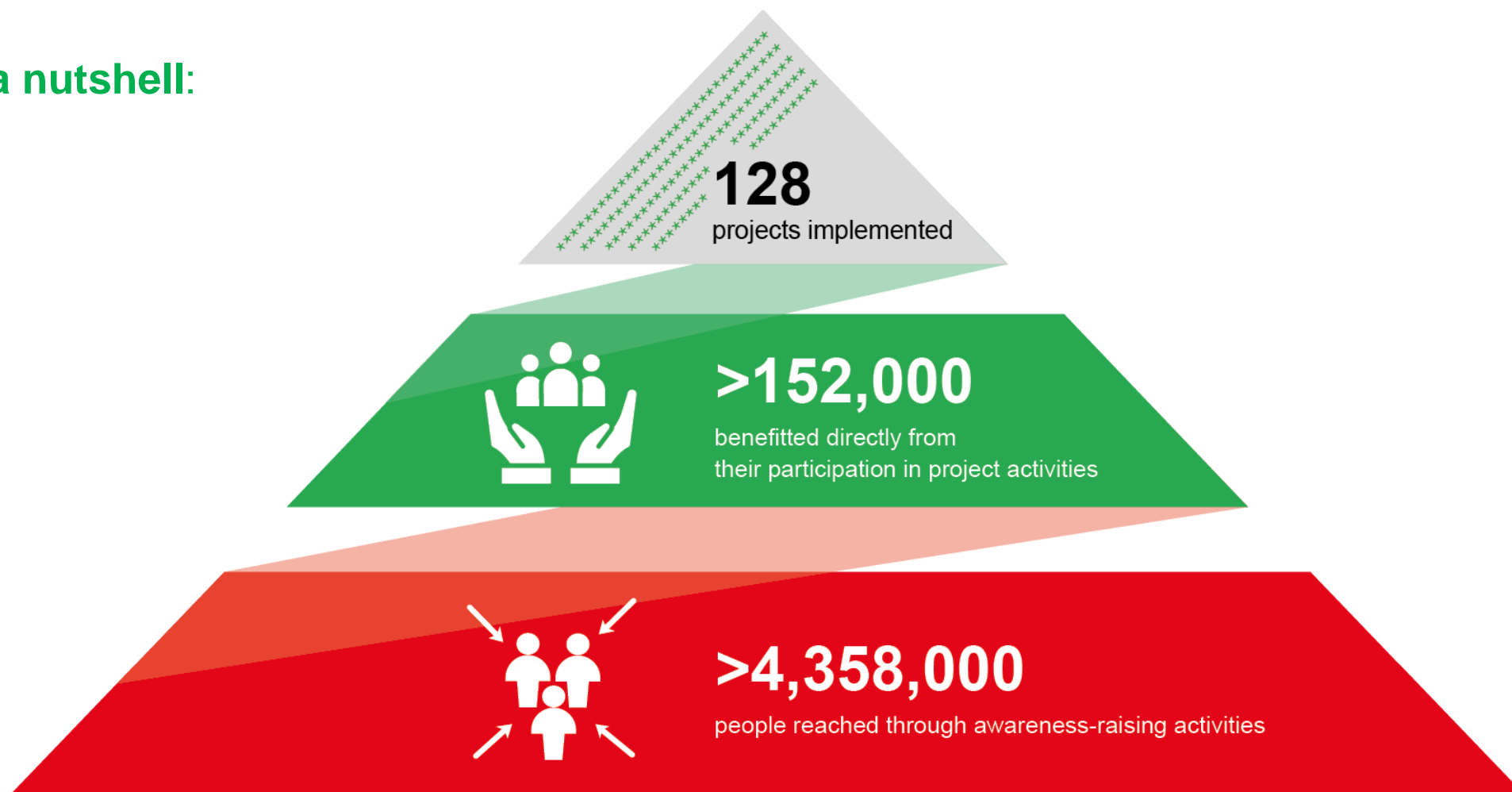

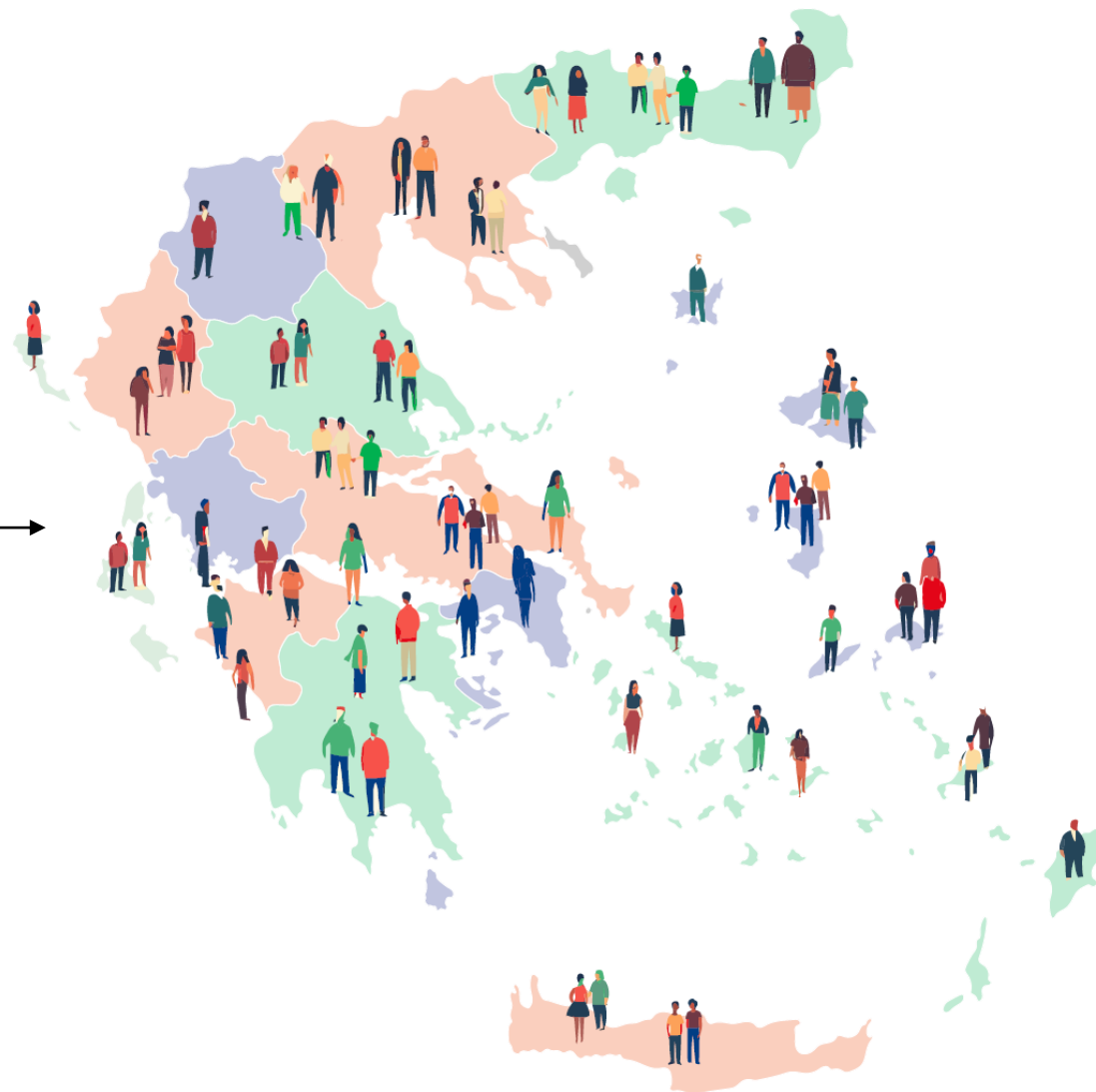

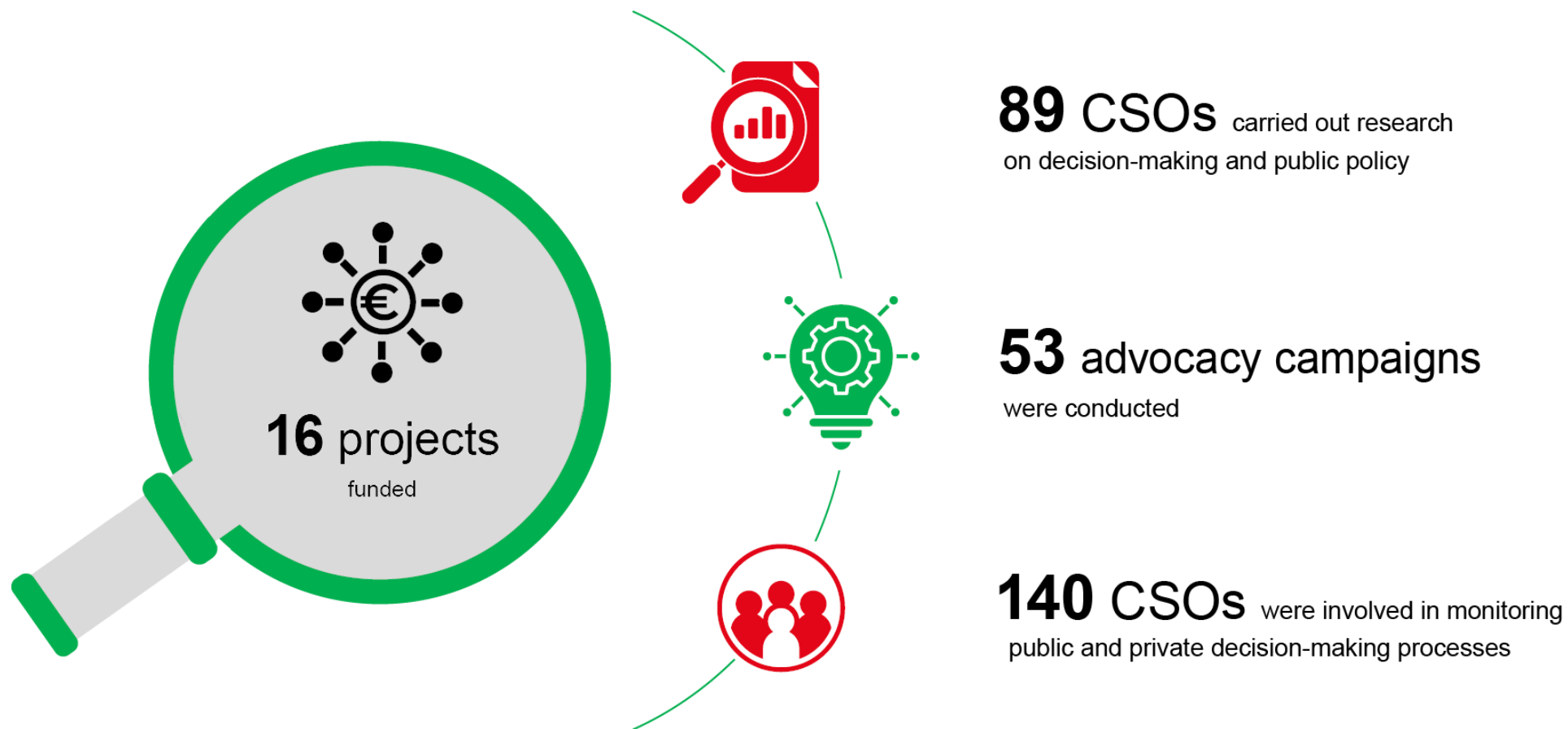
Geographic regions of Greece



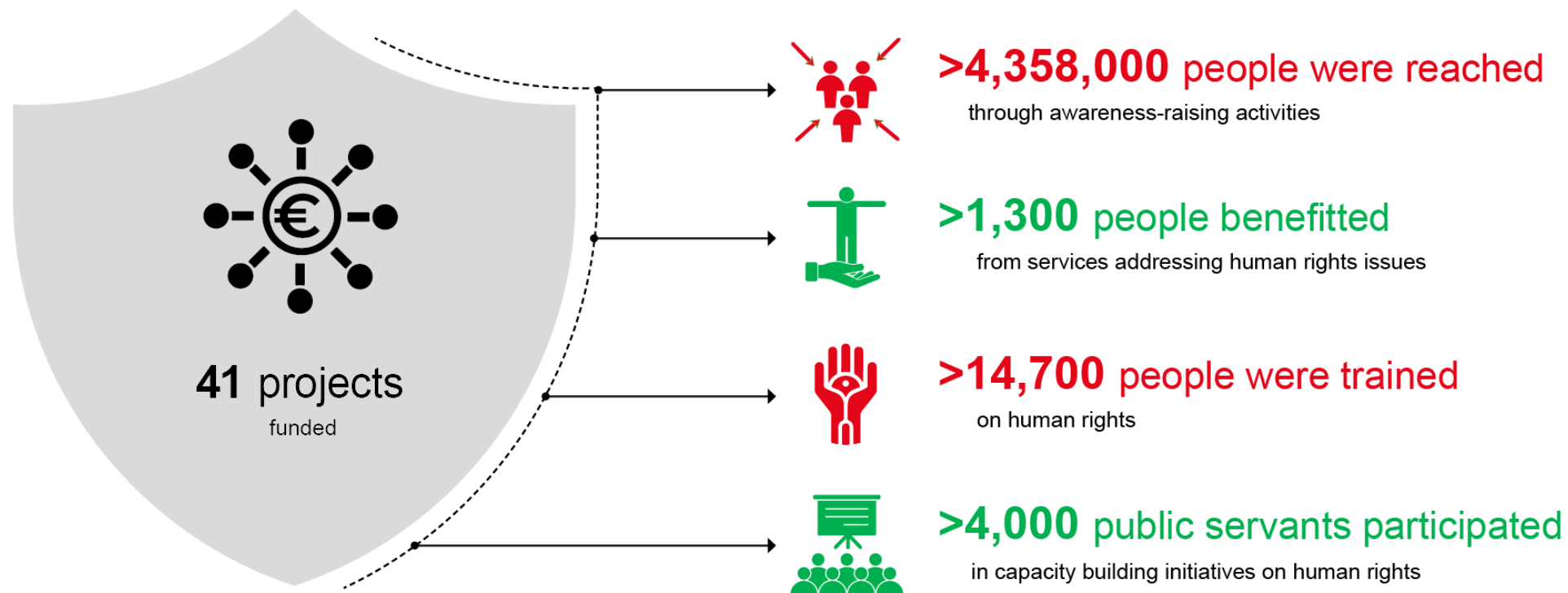

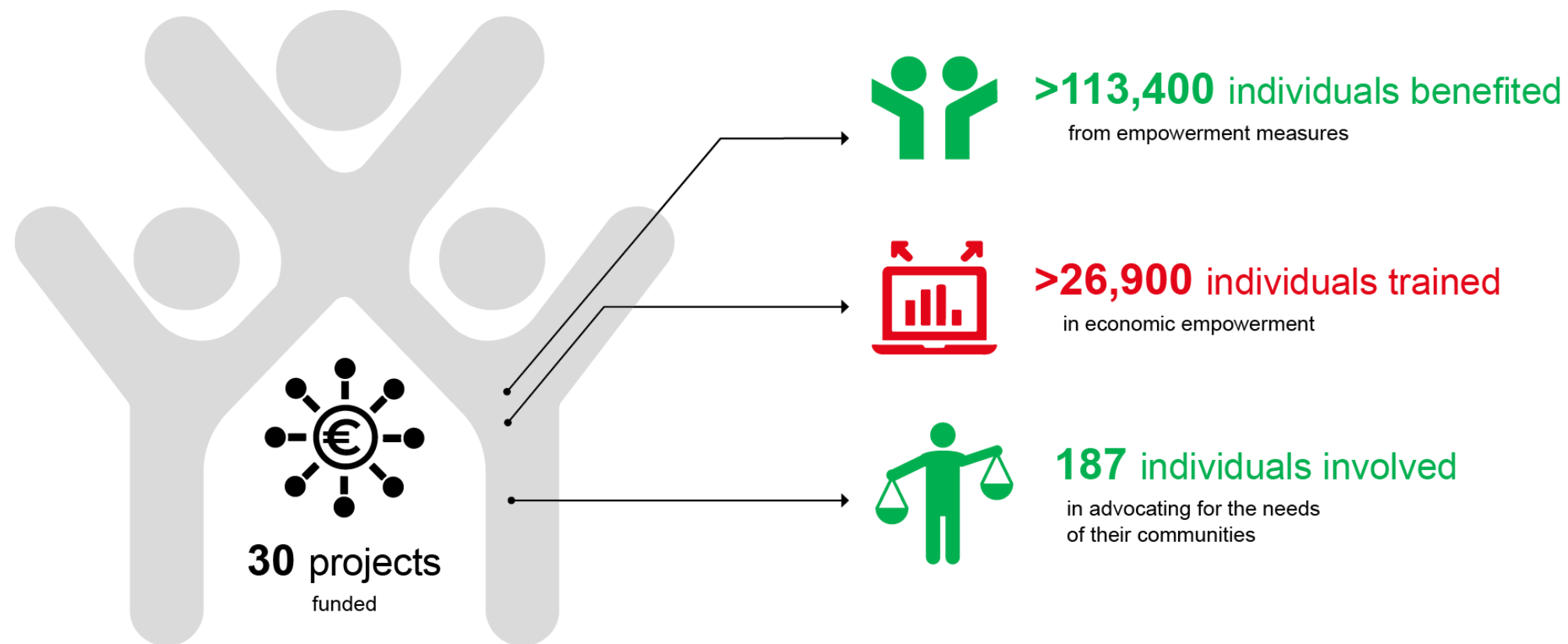

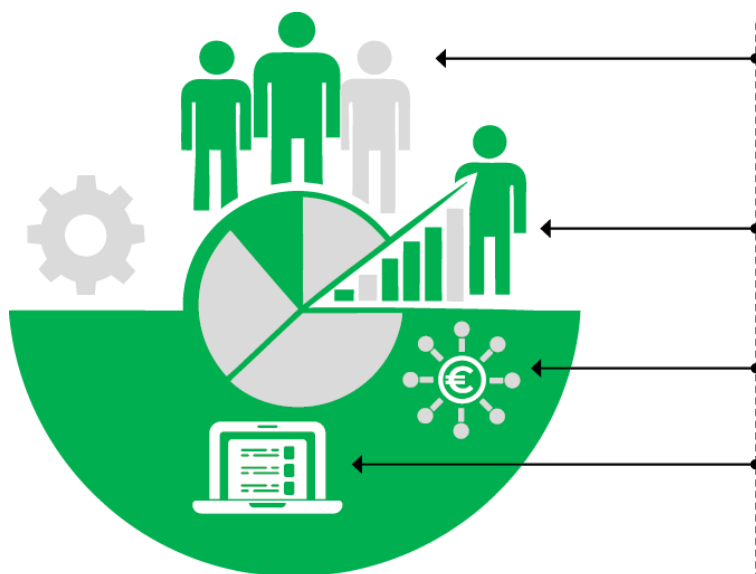

11 CSOs received organisational grants for their institutional development

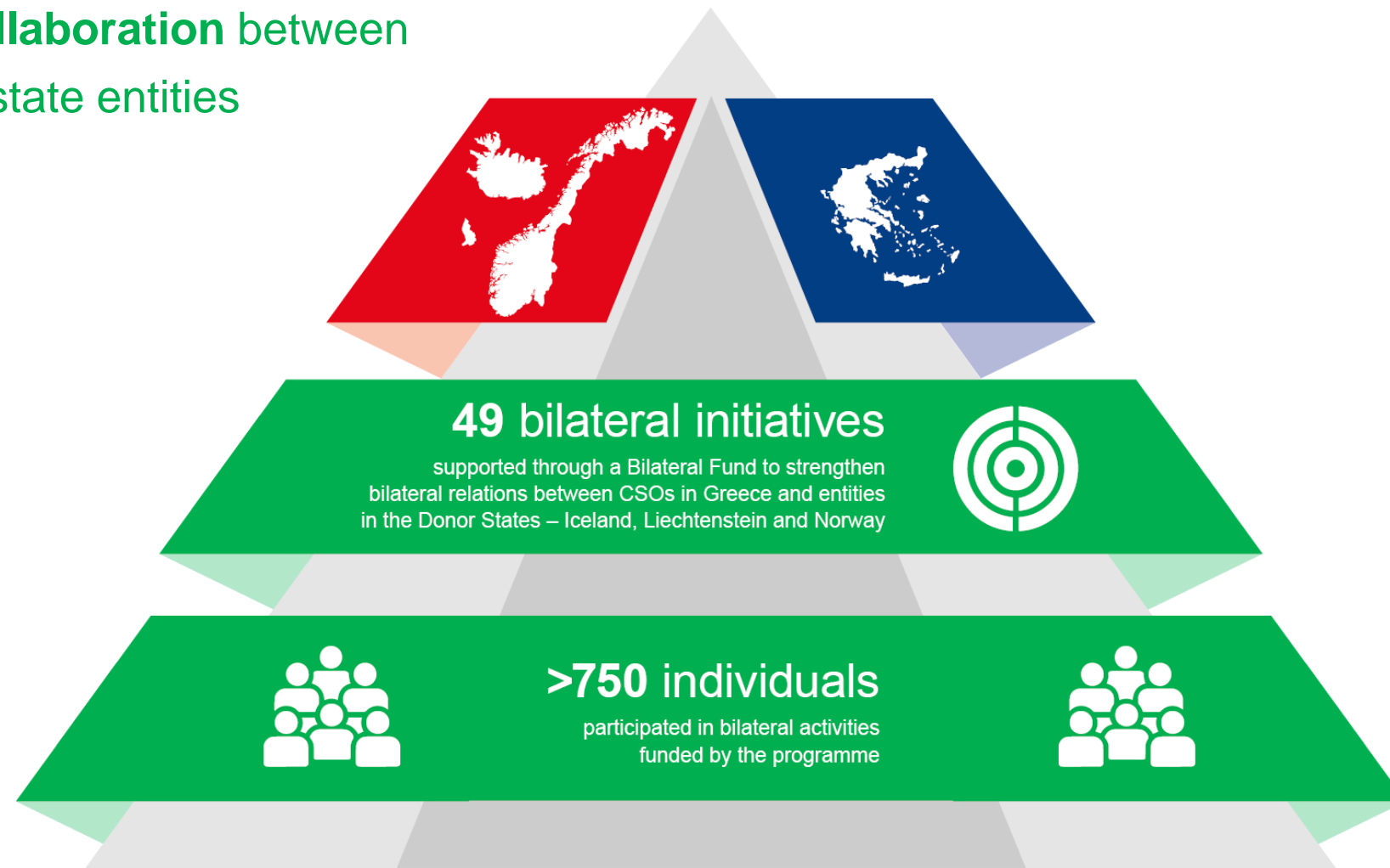
12 CSO platforms and networks were funded, involving **321** CSOs

Legacies & lessons learned

5 key legacies:

- Increased **organisational capacity and sustainability** of the project promoters
 - Promotion of **collaboration** and **collective bodies**: 12 networks funded, with a total membership of over 320 organisations
 - Encouraging and enabling CSOs to be **agents of change**
 - Calculating the **contribution of civil society to the Greek economy** for first time
 - 49 collaborations between **Greek and donor state CSOs**

Lessons learned for future programmes:

- Longer project implementation period
- 100% funding rate
- Increased use of organisational grants
- Simplification/ streamlining of reporting
