## Building Integrity, Strengthening Democracy

Integrity is not built in a day — and certainly not on paper. It grows within institutions that take responsibility, train their people, and open space for dialogue.

This belief formed the core of the EEA Grants-funded project “**Strengthening of the integrity, transparency, and anti-corruption framework**,” implemented by the [National Transparency Authority](#) (NTA) in collaboration with the [OECD](#), under the programme “[Good Governance, Accountable Institutions, Transparency](#).”

### A national effort for public trust

The project supported the implementation of the **National Strategic Plan for the Prevention of Corruption** — the country’s key framework for preventing and combating corruption.

Through targeted actions, it strengthened the integrity and accountability of Greece’s public sector:

- Establishing a **National Integrity System** to enhance consistency and transparency.
- Developing **tools and best practices** to regulate conflicts of interest and manage risks.
- Creating a **digital training platform** with 16 professional video lessons on integrity issues. Researching the implementation and impact of integrity policies.

- Hosting a **national conference** to share results and promote dialogue among institutions, experts, and civil society.

## From strategy to everyday practice

What makes this project stand out is how it connects *policy to practice*. Integrity principles only matter when they reach the daily decisions of public servants — the choices that shape citizens' experience of fairness and trust.

That's why the project launched a **web-based training platform** accessible to thousands of officials. Through interactive lessons, public servants strengthen their skills, critical thinking, and ethical awareness — transforming institutional values into everyday action.

At the same time, a **perception survey of 3,000 civil servants** captured awareness and attitudes toward integrity safeguards. The insights will guide future training and policy design, making Greece's integrity framework both data-driven and people-focused.

## Knowledge that shapes reform

Among the project's key deliverables are two major **policy reports prepared by the OECD**, which mapped national and international best practices and proposed concrete legislative reforms to regulate conflicts of interest. These reports are already informing Greece's future steps, aligned with **GRECO recommendations** and national strategies such as the **National Anti-Corruption Action Plan (NACAP)**.
